Chairman's Report

- 7. Finally, we expect that the Society's Annual Conference will again be held on a virtual basis in November later this year, with a view to a return to an in-person Conference next year.

Treasurer's Report

For Discussion at the delayed AGM on 6 May 2021

For Financial Year Ending 31st December 2019

The Accounts

There was no AGM at the virtual Annual Conference on 29 October 2020. Accordingly, this is the Treasurer's Report for the delayed AGM on 6 May 2021 and the accounts are for the financial year ending 31st December 2019. The accounts for the financial year ending 31st December 2020 will be prepared in advance of the AGM due to be held in November 2021.

The Society is in a very good financial position with significant financial reserves. There are no current plans to increase spending and there are no flagship project(s) that require significant money.

Put simply, the Society has seven distinct bank accounts and approximately £143,907.96 in its reserves. These are set out below with the levels as at 31st December 2019.

- Progressive Building Society £57,007.88
- NatWest Treasury Bond £28,888.49
- NatWest Current Account £52,615.81
- Northern Ireland Region £1,885.60
- London/South East Region £140.81
- Midlands Region £1,751.47
- South West/Bristol £1,617.90

As for previous Financial Years the Society is not required to have full audited accounts for filing at Companies House, so we have proceeded on the basis of Unaudited Accounts prepared by CH Accountancy Ltd, Chartered Accountants and take the form of:

- The Chartered Accountants' Report to the Society
- The Profit and Loss Account
- The Balance Sheet
- Notes to the Accounts

A copy of accounts for year ending 31st December 2019 have been circulated in advance of the AGM. The "Headline" is that in financial terms 2019 saw a decrease in profit compared to 2018. In 2019 there was a profit of £8,678.00, whereas in 2018 the profit was £17,985.00. The primary reason for this is the venue hire cost for the Annual Conference, which in 2019 was held in London and was significantly more expensive than the venue hire cost for the Annual Conference in 2018, which was held in Bristol.

In terms of a financial SWOT Analysis the Society has the opportunity to increase its financial reserves and in that context the Committee will seek to consider the following:

- 6.1 **An Annual Lunch or Dinner**. Such an event would generate additional income and profit, which could be used for other initiatives and/or increasing the Society's financial reserves.
- 6.2 **Inviting Law Firms to host the Annual Conference**. As one of the single biggest annual expenses the Society has to bear, this could result in significant savings and an improvement on the future balance sheets.

Summary of Year 2019

In 2019 the Annual income was £41,899.00, down slightly from £46,287.00 in 2018. Of the Annual income, over half came from membership subscriptions and the balance from the Annual Conference.

The 2019 expenditure included £18,762.00 for the Annual Conference compared to £10,390.00 in 2018. Other significant expenditure include £7,500 for Research Funding.

The Conference

The Annual Conference continues to be the Society's main event and is organised by a sub-committee. The members rate remains as low as possible.

The discounted rate for students will continue.

Proposals

It is proposed that:

- The subscription is not adjusted
- The regions are invited to apply for additional funding for extraordinary events
- The Conference will continue to be offered at current rates.
